# 6. Actions from Previous Meetings

Action: YCPAG and Shire Officers to develop public art projects in Yarloop.

Library Early Years and Art and Culture and Performing Arts Advisory Group (LEAP) has the following two actions relating to current art projects in Yarloop:

 Action 16: take intramap to show Shire spaces to Yarloop and Surrounding Areas PAG to determine locations for art installation.  Action 18: Need to revisit ARC infrastructure approval for Yarloop Mural. Shire to investigate opportunities to seek funding for an art installation in an alternative location that invites people into town.

The relationship between Shire and ARC Infrastructure is delicate as there appears to be a blanket policy that prohibits interaction with their property. We need to look carefully at what we propose for their land.

Discussion deferred until LEAP Community Development Officer is able to attend the next YPAG.

**Action**: Shire Officers to investigate if the owner of the building beside the general store can repair the hole in the wall.

New Compliance Officer to investigate.

**Action:** Shire Officers to send information regarding caravan stays at Yarloop Recreation Park to the Yarloop CRC.

Discussion regarding current information signs and increase in patronage due to homelessness crisis.

Council has endorsed Yarloop as an RV-friendly town. Located within the Yarloop Recreation Grounds, Yarloop's RV Short Stay offers four sites with free parking available for up to 48 Hours for recreation vehicles and caravans.

Discussion regarding historical caravan stays, rubbish left behind and revenue generated for Yarloop town. Maintaining anti-social behaviour, rubbish pollution and behaviour is an ongoing action for all RV friendly sites in the Shire.

**Action:** Director of Sustainable Development to investigate process regarding Yarloop Equestrian Association leasing suitable land.

Yarloop Equestrian Association signed Memorandum of Understanding with South-West Horse Trust.

Discussion regarding stormwater drainage issue from Railway crossing on Clifton Road down towards property on corner Railway Parade and Clifton Road.

Action: Investigate stormwater drainage corner Clifton Road and Railway Parade

 Discussion regarding lack of perceived organisation and communication of car shows and car cruises held on Yarloop Recreation Ground. Further discussion regarding social disruption caused by some car show attendees.

**Action**: Shire Officers to investigate if car shows held at Yarloop are approved by the Shire.

## 8.1 Shire Update

#### Office of the CEO

Yarloop Workshops update

The Projects Team has re-commenced the Yarloop Workshops redevelopment stage 1. In preparation for construction the Shire has engaged a consulting team and in conjunction with the Yarloop Workshop Committee have been putting together a revised scope for the completion of the works.

To date, the following has been completed:

- Engagement of Perkins Builders as the lead consultant to re-commence the project.
- Review of the existing structures on site, engineering solutions put in place to brace the existing buildings.
- Site clean-up and inventory of materials has commenced.
- Consulting Team has reviewed the plans and is preparing amended drawings to complete the works in a cost-effective manner.
- Regulatory approvals will commence once the drawings are finalised.
- Construction will commence in the coming months.
- Perkins to complete the building works and hand over to the Shire early 2025 until future stages of the completion of works are carried out.
- Carparking, hardstand areas and external services to be completed by the Shire after the contract.
- Remaining Fit- out for future Workshops Museum Foyer/ Reception etc to be determined after the construction is completed - pending additional funding.

Further updates will be provided to stakeholders and the general public as the project progresses. Keep an eye on the Shire website for key updates and progress.

Discussion to communicate Yarloop Workshop updates online and in the Harvey Waroona Reporter.

**Action:** Shire to communicate Yarloop Workshops update in the 4 O'clock report and the Yarloop noticeboard Facebook page.

Discussion regarding incidences theft from Yarloop Workshop site. Community members asked to remain vigilant for suspicious behaviour around the Workshop site and report to local Police.
